## 6. 泄露应急处理 Accidental release measures

为防止电池材料泄露或释放采取的措施  
如果电池内部材料泄露, 试验人员应立即撤离试验区直到烟气消散。将通风设备打开吹散危险性气体。用抹布擦净试验区, 清除溢出的液体, 将泄露电池放进塑料袋中, 然后放进钢制容器。首选的反应是离开该区域, 让电池冷却, 蒸汽消散, 避免皮肤和眼睛接触或吸入蒸汽。  
**Steps to be Taken in case Material is Released or Spilled**  
If the battery material is released, remove personnel from area until fumes dissipate. Provide maximum ventilation to clear out hazardous gases. Wipe it up with a cloth, and dispose of it in a plastic bag and put into a steel can. The preferred response is to leave the area and allow the battery to cool and vapors to dissipate. Avoid skin and eye contact or inhalation of vapors.

## 7. 操作处置和储存

### Handling and storage

Do not short circuit terminals, or over charge the battery, forced over-discharge, throw to fire. Do not crush or puncture the battery, or immerse in liquids.
